Options to Pay Net Cost

Loans

Borrowed money which you are responsible for repaying with interest (<https://studentaid.gov/understand-aid/types/loans/interest-rates#rates>) ">. The U.S. Department of Education pays the interest on Federal Direct Subsidized Loans while you are enrolled at least half-time. Because interest that accrues on Federal Unsubsidized and Federal PLUS Loans is added to your outstanding principal after you graduate or drop below half-time status, we encourage students to consider paying the interest on these loans while enrolled.
