The Office of Financial Aid has carefully reviewed the financial information you provided to us. Based on our review, we are pleased to inform you that you qualify for **a full tuition Hurst Horizon Scholarship** for the 2025-2026 academic year. The Hurst Horizon Scholarship is awarded to eligible J.D. students with significant financial need to cover the full cost of tuition and mandatory fees. The scholarship will ensure that you can fully immerse in the rich academic experience and benefit from the resources and opportunities that Yale Law School has to offer.

The following planning worksheet will help you understand how your net cost to attend YLS is determined, as well as the options and resources related to financing your law school expenses. In addition, you may be eligible for aid from non-YLS sources such as scholarships from outside organizations. Outside scholarships reduce need-based loans dollar-for-dollar, and only impacts institutional scholarship if loans have been fully reduced.

We are committed to making the process of paying for your law school education as clear as possible. Our office is open Monday through Friday from 8:30am to 4:30pm, and our financial aid team is available to answer your questions. If your financial situation has changed since you submitted your application materials, if there is additional information that has not been submitted, or if you think your aid package does not adequately take into account your current circumstances, please contact a counselor to discuss requesting a review of our analysis. Please use the Budget Revision/Financial Aid Appeal Form from our website to guide you in your request.

Your Hurst Horizon Scholarship is subject to federal and institutional verification requests. You are required to submit student and parent tax returns to complete the verification process. If you are 29 or over, verification of parental income and assets will also be required. We will notify you if additional information is required to verify the financial information you provided.
